# 1. WELCOME: Call to Order and Identity of Hearing Officer.

Hearing Officer: Welcome. This public hearing is now open; it is 9:30 a.m. My name is

Karen Fiala I am Manager of Tax Incentives of the Erie County Industrial Development Agency, and I have been designated by the Agency to be the

hearing officer to conduct this public hearing.

# 2. PURPOSE: Purpose of the Hearing.

Hearing Officer: We are here to hold the public hearing on the Niagara Wind Power, LLC

and/or Individual(s) or Affiliate(s), Subsidiary(ies), or Entity(ies) formed or to be formed on its behalf project. The transcript of this hearing will be reviewed and considered by the Agency in determination of this project. Notice of this hearing appeared in <a href="The Buffalo News">The Buffalo News</a> on Friday,

November 8, 2019.

# 3. PROJECT SUMMARY: Description of Project and Contemplated Agency Benefits.

Hearing Officer: The proposed project (the "Project") consists of: (i) the acquisition

by the Agency of a leasehold interest in eight (8) parcels of land located at 2303 Hamburg Turnpike in the City of Lackawanna, Erie County, New York (the "Land") together with eight (8) 2.5

megawatts wind turbines (the "Existing Improvements"), (ii) the replacement and upgrading of the Existing Improvements without changing the existing towers, foundations and electrical equipment (the "Improvements"), and (iii) the acquisition and installation by the Company of certain items of machinery, equipment and other tangible personal property necessary for the operation of the wind energy generation facility (the "Equipment", and collectively with the Land, the Existing Improvements and the Improvements, the "Facility").

The Agency will acquire a leasehold interest in the Facility and lease the Facility back to the Company. The Company will operate the Facility during the term of the lease. At the end of the lease term, the leasehold interest will be terminated. The Agency proposes to provide financial assistance to the Company in the form of a lease for a term of fifteen (15) years and a partial tax abatement of real property taxes for the term of the lease. The proposed financial assistance deviates from the Agency's UTEP in the following respect:

Payments under the PILOT Agreement deviate from the UTEP as they will be based upon megawatts generated by the Facility in connection with the operation thereof and not based upon the assessed value of the Project. The Agency proposes to deviate from the UTEP given the nature of the Project and that the Project will provide a benefit not otherwise available within the locale of the Facility.

# 4. FORMAT OF HEARING: Review rules and manner in which the hearing will proceed.

There are no limitations on written comments.

# 5. PUBLIC COMMENT: Hearing Officer gives the Public an opportunity to speak.

Hearing Officer: If anyone is interested in making a comment, please raise your hand, state your name and address; if you are representing a company, please identify the company. I request that speakers keep comments to 5 minutes, and if possible, 3 minutes.

Thank you. My name is Kevin McAuliffe, I am an attorney with Barclay Damon in Syracuse. I'm here representing Niagara Wind Power on its application to the IDA. This is a major replacement of the component parts at the top of each one of the eight turbines located within the City of Lackawanna and it is necessitated by virtue of the failure of the existing clipper equipment. The company is faced with the choice of either decommissioning the entire wind farm in the next two years or investing as it is proposed to do to replace the nacelles, rotors, blades and hubs on each turbine. The new equipment will be manufactured by GE. There are no changes to the towers themselves, simply the placement of the new equipment at the top of each tower. The ECIDA PILOT would replace a series of PILOTS in place with the City of Lackawanna.

My name is Jeff Basty, originally born and raised in Lackawanna, New York but presently residing in Lancaster, New York. After reading the Sunday paper concerning this meeting being held, various questions arose in my mind as to lease agreements, tax incentives and a host of other questions and my main question at this time is I have questions concerning the lease agreement, when it started, when it expires and my next question would be is there some sort of guarantee that if this financial aid and incentives are not granted to the company requesting this incentive, if they do decide to cancel or stop manufacturing electricity because of this, and they do in fact stop producing electricity after a two year period does the lease expire? I'd like some more information on the lease agreement. I would like information on who will be supplying the new equipment, where its coming from the research that's involved in the new blades. I'm not so concerned about the information concerning knocking down of the birds and the bats, which was highlighted in the newspaper, but my concern is not so much a concern, but I'm here because I would like to see Lackawanna great again and I think that the county or the city should step up and let this contract expire, let it fail and that the city or county should step forward and take on the wind farm itself so it can produce electricity for the people of Lackawanna and Hamburg. And I'd also like a copy of what you read because there is information in there that I would like to further look into.

Karen Fiala – OK, I can certainly get that for you.

Jeff Basty – Thank you.

John Kwasniewski – Almost a ditto to what the gentlemen just said. What I am interested in is the blades are being changed – first it starts with the towers. The towers make them taller, so they're changing the tower. They're changing the motors, the generators and they're changing the blades, the length of the blades and everything. So that's like putting up a whole new system which should do something with the contract that they have with them. It's like starting all over again, brand new, which I think the City should look into for their tax base. See what they're getting. Go to Hamburg, get theirs, see what they got too; see what their contract includes. That's mostly what I'm interested in is for the people here to benefit somehow out of this. I think they could benefit a little more because we were like the first ones that did this contract here. So I think the contract should be updated. Thank you.

Hi, my names is Janet Lenichek, I'm with the Sierra Club Niagara Group, which is the local Sierra club. Just so you know, we are generally in support of renewable energy projects. We want to make sure that they are sited appropriately, which we feel this is an appropriate siting and we also want to make sure they are environmentally sound. And all these projects have to go through an environmental review. So this had passed environmental review so we support continuing this project. We would like to see it upgraded with new equipment, so it runs 99 percent of the time. We understand there will be times when it will not be able to run probably due to weather or whatever, but we would like to see it more functional and producing more energy because New York State now has passed the Climate Leadership and Community Protection Act that was signed into law in June and that commits New York State to receiving 70 percent of its electricity from renewables by 2030 and if we start closing down projects such as Steel Winds we're not going to reach that goal. We need to enhance these projects, and this one im particular is well sited because it doesn't sit on farm land, it sits on an old industrial site that's a brownfield so it's a perfect location and who knows who might even be able to add solar to it at some point. Whether Lackawanna wants to review the contract in detail to make sure they're getting the best deal, that's fine but we support continuing the Steel Winds project.

Karen Fiala – thank you Janet.

If there are no further comments, will you sign in please.

My name is John Thomas Halligan. I'm just here to say that if this company gets all these tax incentives that there should be some sort of local hire agreement that's attached to these incentives. A lot of these wind farm developers come in and hire a lot of out of state contractors. Those windmills were actually installed originally with one of the local contractors from our area, but now a days you see a lot of out of town that use a lot of out of state workers and there should definitely be some sort of labor agreement that's attached to these incentives.

I am wholly in favor of the proposal to have the ECIDA acquire a leasehold interest in the facility in order for the above noted LLC to make significant upgrades to improve both the power output as well as to reduce the intermittency of its operations due to aging equipment. We need this carbon free energy project (and many more like this) to slow down the warming of our planet due to the burning of fossil fuels.

But, I am speaking as an environmentalist who is concerned with the world my children will inherit. There are two non-environmental reasons to approve this proposal. First, wind is already the cheapest source of electricity. New equipment will drive down the price even further.
