#### **Company Description**

Gemcor was founded in 1937 and first developed the Drivmatic<sup>™</sup> process in the early 1940's. This process is used around the world for automatically fastening airframe assemblies. Throughout the world Gemcor equipment and systems are used by virtually every commercial aircraft. The company's facility encompasses 60,000 sq. ft. devoted to manufacturing and 20,000 sq. ft. of office. The facility, which is Gemcor's main headquarters, houses its engineering, sales, service, parts and manufacturing operations.

As part of its venture capital investment program the ECIDA holds a 1/3 equity interest in Gemcor II, LLC. Counsel for the ECIDA has expressed the opinion that this ownership interest does not constitute a conflict of interest with respect to the project.

## **Project Description**

The project consists of the expansion of the company's existing 80,000 sq. ft. complex with the construction of a 27,000 sq. ft. addition for use as additional manufacturing space.
