



Ricotta & Visco is a law firm which provides high quality legal services to the health care community. The firm's attorneys are primarily engaged in the defense of medical malpractice claims and in the defense of personal injury, product liability, legal professional malpractice and general negligence matters.

Project Description

The project involves the rehab and adaptive reuse of this 11,440 sq. ft. facility. Ricotta and Visco will be the sole tenants. The building is best suited for use by a single tenant due primarily to the small footprint of each floor which is approximately 300 sq. ft. The top three floors of this building have been vacant for over fifty years. Significant expenditures are required to restore the facility while adhering to current building codes including adding an elevator, additional staircase and sprinkler system.

The facility is located next to the Belasario.
