

Company Description

Ellicott Development will be forming a corporation (1291 Group, LLC) for the purposes of constructing this project. The sole tenant, The Health Sciences Charter School, was established in the summer 2010.

The impetus for founding the Health Sciences Charter School is the critical shortage of skilled workers to fill the many healthrelated positions that remain unfilled in the Buffalo Niagara Region. Theses include nurses, medical technicians, therapists, pharmacists, health information technology specialists or technicians, case managers and numerous other skilled personnel needed to keep hospitals and other health providers fully staffed with qualified workers.

Project Description

The project consists of the acquisition and total rehab of 1140 Ellicott Street. The five-story 46,000 sq. ft. brick and stone building has been vacant since 1982. Former uses of the property include St. Vincent's Orphanage, Bishop O'Hern HS and ECC City Campus.

The property will undergo a multi-phase renovation. Most, if not all, windows either are missing or beyond repair. They will be replaced with new energy efficient windows. All new mechanicals including plumbing, electrical and HVAC are required.

The school is currently housed in the Town of Tonawanda at 169 Sheridan Drive. The additional space provided at the new location will allow for expanded classes and the addition of students and faculty. Also, by having its own dedicated property, the school will maintain full control of the space and maximize flexibility for additional programming and extracurricular activities.
