#### **Agency Request**

Sales tax, mortgage recording tax and real property tax exemption in connection with the construction and/or renovation, expansion, upgrading and equipping of improvements of a 45,000 sq. ft. addition to the existing facility and the acquisition and installation of machinery and equipment.

## **Company Description**

Goya Foods Inc. has approximately 1600 products that are currently available. The products are food items that are primarily marketed toward the Hispanic population and distributed worldwide. Two thousand five hundred employees worldwide produce and distribute products that are available in local grocery stores and supermarkets. Other manufacturing facilities are located in New Jersey, Puerto Rico, Spain, Dominican Republic, Massachusetts, Illinois, Florida, Texas, California and Virginia. The existing facilities consist of a 40,000 sq. ft. distribution facility and a 138,000 sq. ft. processing plant and a 150,000 sq. ft. distribution facility constructed in 2007.

# **Project Description**

The project consists of the construction of a 45,000 sq. ft. expansion of the existing manufacturing facility. In addition, new manufacturing equipment will be purchased which will speed up the bean soaking process.

#### **Project Benefit**
