Company Description

Eastman Machine Company is a cutting machine manufacturer, providing custom engineered solutions and innovative technologies for a variety of industries. Eastman serves customers in almost every country from its world headquarters in Buffalo, New York (USA), and through an international network of sales, support and engineering staff.

Eastman manufactures hand-held and manually-operated fabric cutting machines built to precise specifications; as well as a comprehensive line of fully automated, computerized cutting and plotting systems.

The company was founded in 1888 by George Eastman. Between 40 and 50% of sales are to customers outside the U.S.

The ECIDA has had a long history with the company dating back to 1982 with the issuance of a \$2M industrial revenue bond. Subsequently the Regional Development Corporation ("RDC") and Industrial Land Development Corporation ("ILDC") assisted the company with several working capital loans, two of which are outstanding and paying as agreed.

They are located in the City of Buffalo in a 120,000 sq. ft. two-story facility containing manufacturing, assembly & storage areas on the first floor and offices, conference rooms, repair and assembly on the second floor.

Project Description

Companies like Eastman face competition both domestically and abroad and forces them to maintain facilities at peak performance.

The project will involve upgrades to the facility in the form of new wiring/cabling for both telephone and data transmission.

Additional upgrades include:

New Phone System for entire facility (VOIP) New ERP system implementation including software Replacement of AS 400 with a current IBM processor Machinery and equipment for production area A reconfiguration of the production area to expand operations and allow contract work, currently being performed by an outside company to be done in-house.
