Utilizing IMPLAN Pro modeling software, an economic impact analysis was conducted to measure new investment and employment for the Bryant & Stratton / BP Southtowns Campus LLC, JP Southtowns Campus LLC and B&S Southtowns Campus Group, LLC Project. IMPLAN Pro is a widely accepted software application and an industry standard for economic impact modeling measuring employment and salary impacts and facility output on the community for a given project.

The impacts generated can be measured on an annual basis except for finite activities, such as economic activity occurring as a result of construction investment.
