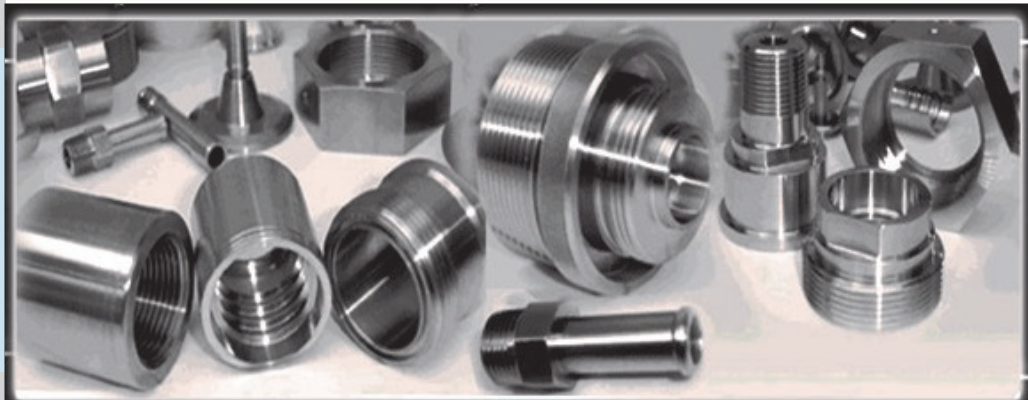

Company Description

Serafin Properties, LLC/QMC Technologies is a manufacturer of stainless steel machined parts. QMC Technologies began operations in 1976 as a machine shop providing short run manufacturing services to area manufacturers. The company works almost exclusively with stainless steel and aluminum. All machining, marking, bagging and shipping is conducted at the facility. Over 90% of its customers are located outside of New York State with a small percentage of sales outside the country. The company has shipped products to customers as far away as Africa, Mexico and South America.

Project Description

The current facility is owned by Serafin Properties, LLC and consists of 15,500 sq. ft. built in 1988.

A total of 9,800 sq. ft. will be added to the facility for raw materials storage, material prep, manufacturing and quality control.

Project Benefits

The project is anticipated to create 3 additional jobs.
