Company Description

TexWeb, Inc. is a subsidiary of Petrolift, Inc. based in Cairo Egypt. Petrolift was established in 1999 to serve the growing need for specialist lifting equipment. They are a leading manufacturer of web slings and lifts for industrial applications in the oil and gas industry.

Project Description

The company is looking to start up operations in the Western New York region and has acquired a 36,000 sq. ft. building in the Town of Eden. The expansion into the U.S. is the result of increased domestic oil and natural gas production in North America. The facility in Eden is in need of considerable rehabilitation. Except for a small fabrication shop which occupies 5,000 sq. ft. of space, the remainder of the building is vacant and in need of substantial repairs. In addition to internal renovations the company plans on installing a new roof and windows.

Recapture

Pursuant to Section 875 of New York General Municipal Law, the agency may recover or recapture from the company any state sales and use tax exemption benefits taken by the company that are in violation of the GML.

In addition, it is the recommendation of the ECIDA's Policy Committee to recapture the local share of sales taxes.

At completion of project company must certify i) total investment amount equal to or greater than 85% of amount proposed ii) confirm that company has met 85% of its projected full time employment and iii) confirm adherence to ECIDA local labor hiring policy.
