### ☒ 3. PROJECT SUMMARY: Description of Project and Contemplated Agency Benefits.

Hearing Officer: *The proposed project (the "Project") consists of: (i) a parcel of land located at 3101 Broadway, Town of Cheektowaga, Erie County, New York (the "Land") to be improved thereon with a new 3,000+/- SF cooling tower; a new 1,600+/- SF addition to the existing substation to allow an additional feed line to their 6,500 hp test stand; and the renovation, upgrading and equipping of existing space to provide infrastructure for future expansion (the "Improvements"), and (ii) the*

*acquisition and installation by the Company of certain items of machinery, equipment and other tangible personal property (the "Equipment," and collectively with the Land and the Improvements, the "Facility").*

*The proposed financial assistance contemplated by the Agency includes New York State and local sales and use tax exemption benefits (in compliance with Agency's uniform tax exemption policy).*

As Grant said, we are doing an expansion of our substation which is an approved project by our corporate Cameron and the value of that is \$2.6 million. And then there is a proposed additional expansion of a cooling tower and variable frequency drives to separate our 6,500 and 11,000 horsepower test stands that is awaiting corporate approval.

I'm Mary Holtz and I'm Town of Cheektowaga Supervisor. I have already sent a letter of support of this project. This company has been here since the 1950s; high paying jobs, good technology company. We want to support them as much as we can. Hopefully they will stay within the Town borders and I want the IDA to support this project as well.
