Company Description

Derrick Corporation was founded in 1951 and has been at its current location since 1954. They are considered the world leader in the design & manufacture of high frequency vibrating machines and screen surfaces. Customers are oil and gas drilling companies and various mining operations. Most customers are multi-national companies located around the world.

Project Description

This project contemplates the construction of a 124,000 sq. ft. addition to the company's existing 230,000 sq. ft. manufacturing plant. The facility will be used to expand the company's manufacturing capacity. In addition, the company is purchasing approximately \$7M in manufacturing equipment which will include cranes, paint booths & a metal shot blaster used to clean metal.
