#### LOAN ADMINISTRATION PLAN

Mr. Cappellino provided general background to Committee members on the history of the RDC Revolving Loan Fund. Mr. Spulecki described proposed changes to the LAP involving new line of credit products for specific trades and specific terms related to the new products, biannual RDC loan interest rate review and potential adjustment, increase in the minimum loan amount from 10K to 20K, requirement that borrower's have been in business for at least one year, and authorizing staff to close loans certain loans.

Mr. Cappellino asked members to review the proposed Loan Administration Plan amendments and stated that the Committee will meet next month to finalize with a

recommendation for the Amended Loan Administration Plan to be approved by the RDC Board of Directors.
