PROJECTS


Disc-Lock, LLC, 400 Riverwalk Parkway, Tonawanda, New York, \$325,000 84-Month term loan, secured and guaranteed. Mr. Manhard presented the application and the loan case. General discussion ensued. Mr. Grys then moved and Ms. LaTulip seconded to approve of the loan request. The motion was then passed unanimously.

General Welding & Fabricating, Inc., 991 Maple Road, Elma, New York, \$500,000 120-Month term loan, secured and guaranteed. It was determined that Loan Committee member Nancy LaTulip is affiliated with the potential co-lender. It has been determined that her position with the potential co-lender does not give rise to a personal interest in the transaction and therefore will not affect her duties as Loan Committee member or the integrity of the Committee

or the contemplated transaction. To avoid the appearance of a conflict of interest, Ms. LaTulip refrained from participation in the consideration of the loan request and also refrained from taking formal action related to the Committee's consideration of granting the loan request. Mr. Alexander presented the loan case and the loan request. General discussion ensued. Mr. Mudie moved and Mr. Grys seconded to approve of the loan request. The motion was passed unanimously with Ms. LaTulip abstaining.

Big Ditch Brewing Company, 55 East Huron Street, Buffalo, New York, \$500,000, 120-Month term loan, secured and guaranteed. It has been determined that her position with the potential co-lender does not give rise to a personal interest in the transaction and therefore will not affect her duties as Loan Committee member or the integrity of the Committee or the contemplated transaction. Mr. Manhard reviewed the loan application and loan case, confirming that loan proceeds will be utilized for equipment purchases and installation of a new canning production line to produce canned product.
